

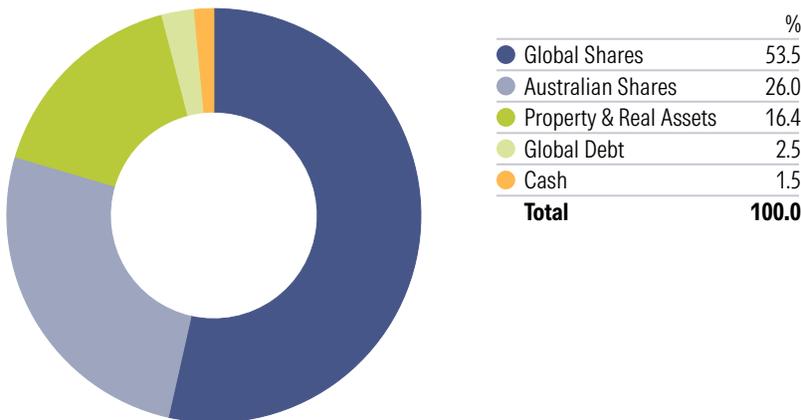

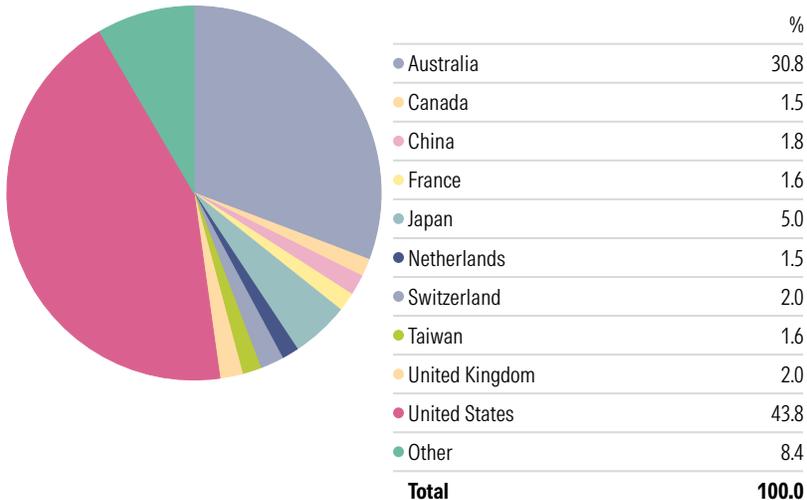
Portfolio Profile

Asset Class Breakdown



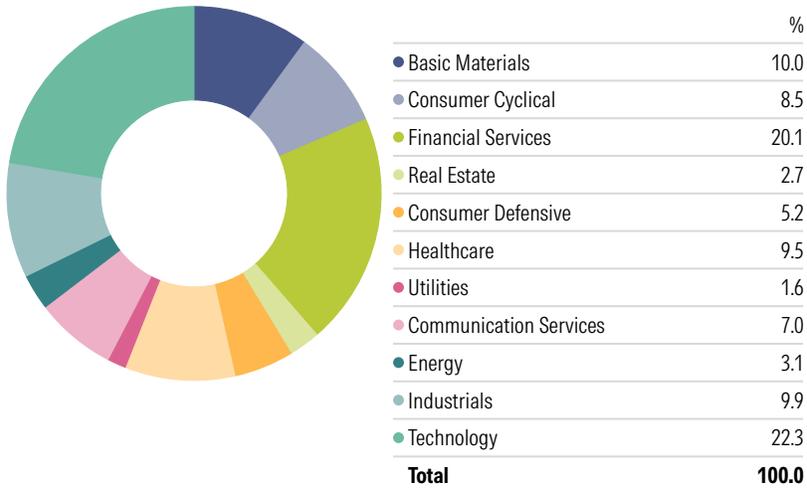

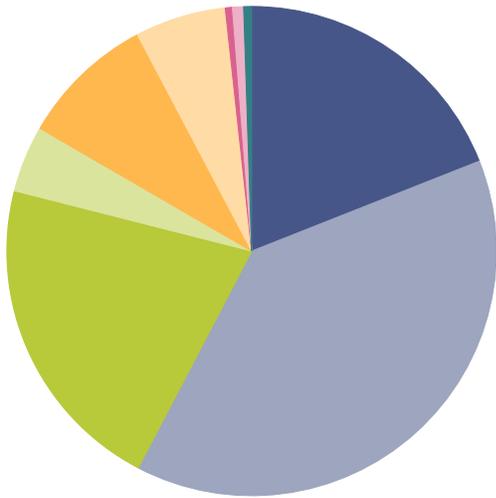

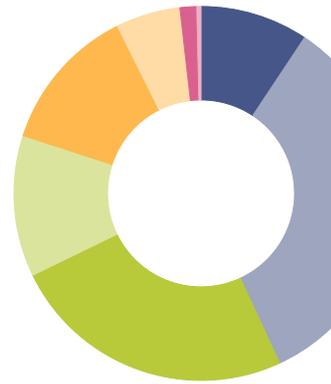
