

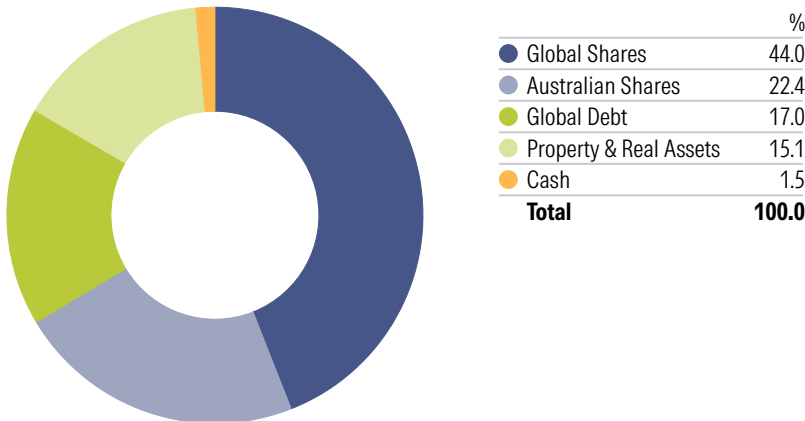

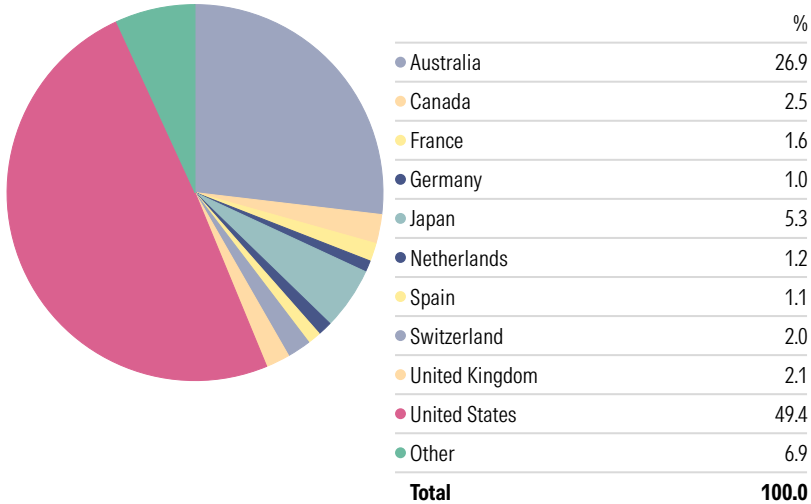
Portfolio Profile

Asset Class Breakdown



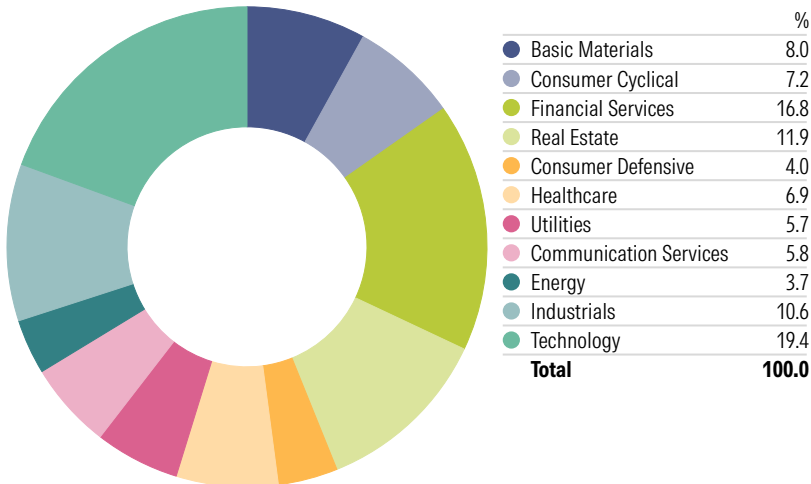

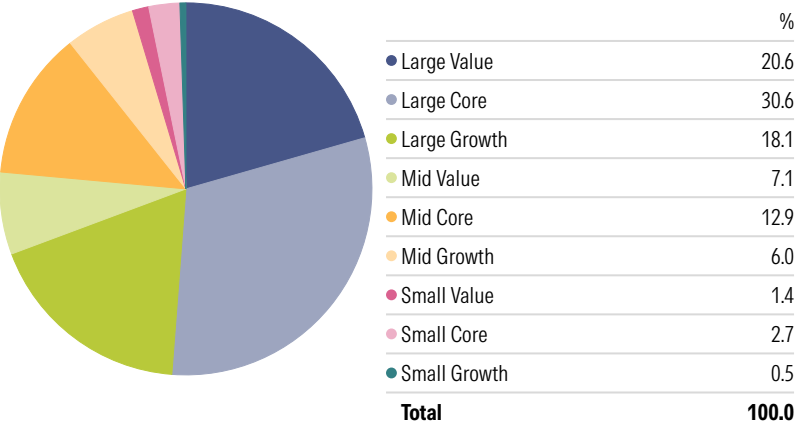

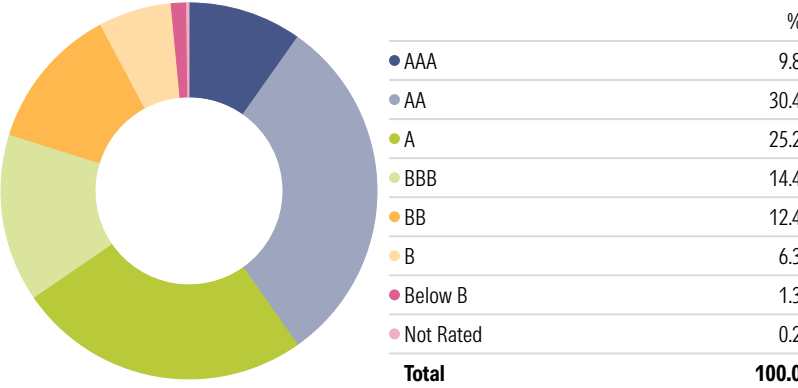

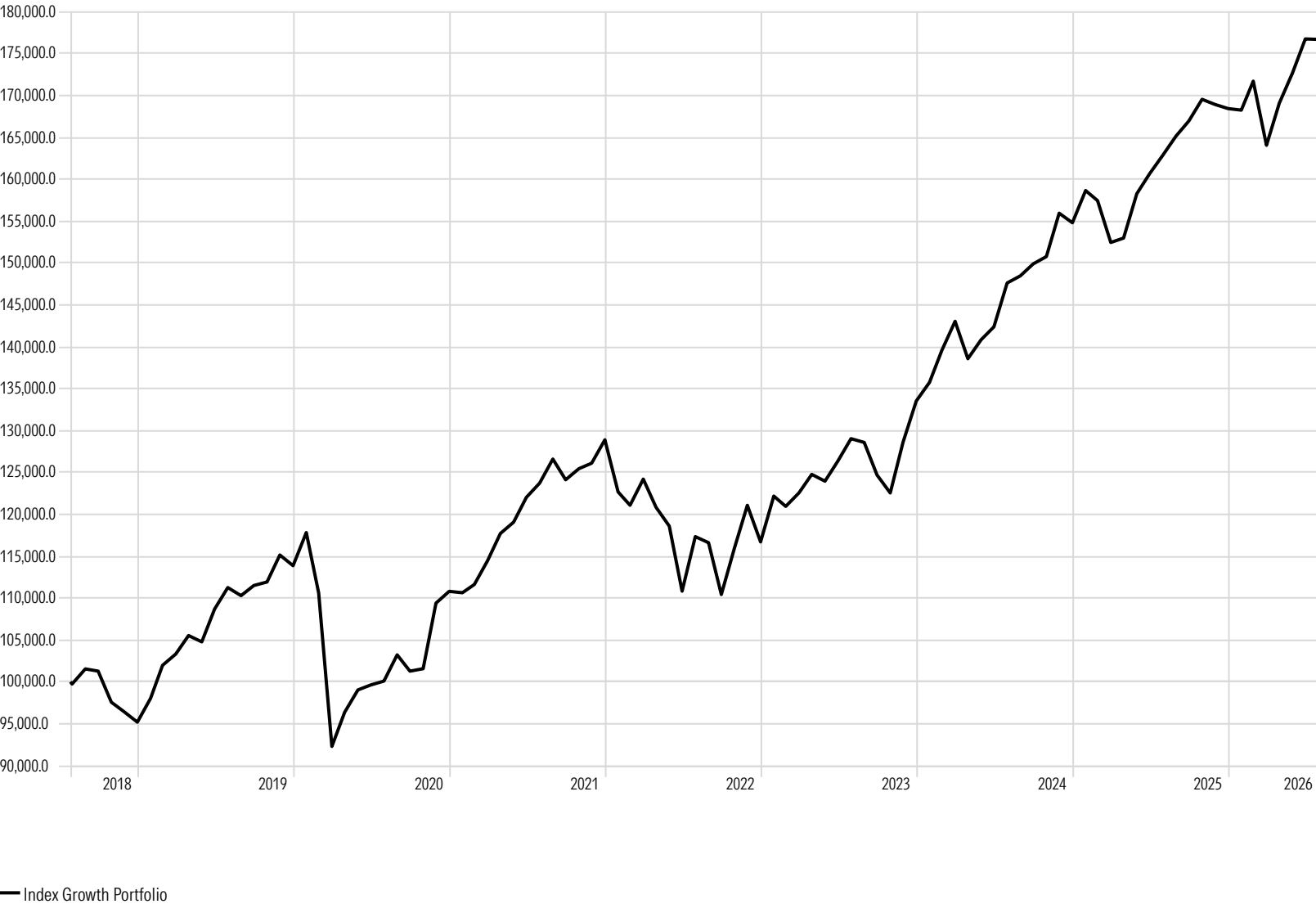
Equity Style Analysis
